### **MISSION STATEMENT**

To provide a facility where alcoholics and their families can achieve and maintain recovery through the meetings and fellowship of Alcoholics Anonymous, Al-Anon Family Groups and Alateen, as well as promoting a greater understanding of the family disease.

### **MANAGEMENT**

A board of Directors, elected annually by the membership, handles the business affairs of the Twenty-Four Hour Club, Inc., oversees the operations and general maintenance of the building and grounds.

### **HISTORY**

In the early 1970s, the Club was founded and built by the donations and volunteer work of a handful of dedicated recovering alcoholics who felt the Naples area was in need of a permanent meeting facility.

### **FINANCIAL**

The Twenty-four Hour Club is a separate entity and is not affiliated with nor financed by Alcoholics Anonymous. In keeping with their traditions, the groups of Alcoholics Anonymous and Al-Anon which meet at the Club pay rent and coffee expenses out of the contributions collected at meetings. However, the income from this source fails to pay all the Club's annual operating expenses. The other source of income is the \$150 per year individual contribution made by the Twenty-Four Hour Club members. The Twenty-Four Hour Club of Naples, Inc. is a Florida not-for-profit corporation and all donations are tax deductible.

The Club relies heavily upon the contributions and support of its membership. Members of the Club need not be a member of A.A. or Al-Anon. We welcome anyone interested in supporting the Twenty-Four Hour club, today and in the future.
